

CINESOL 36 HR. FILM RACE ENTRY FORM 2008

Please read all information before completing and signing the forms!

Clearly record each participant's name, address, contact information, and category (Producer, Director, Scriptwriter, etc.) on the entry form. The **CINESOL 36 HR. FILM RACE** awards prizes for each category, and you must be a registered team member to be eligible to win. Any participant whose entry information is incomplete **WILL NOT BE REGISTERED** and therefore not considered part of the event.

Team members can be listed for more than one category, e.g., one person can be your team's Producer, Cameraperson, and Art Director. You can even be a one-person team, listing your name for all categories. There is no additional fee for this, but there must be **A NAME ENTERED FOR EACH CATEGORY**—even if it means duplicating information. A participant can work with more than one team but must register for each team.

EACH PERSON PARTICIPATING IN THE FILM RACE MUST SIGN A PARTICIPANT RELEASE FORM.

ENTRY FEES

The \$125.00 entry fee covers up to five (5) participants. Additional team members will pay a per-person rate of \$10.00. Each registered team member receives

- (1) one comp ticket for the screening films September 6, 2008 and**
- (2) an Official **CINESOL 36 HR.** T-Shirt.**

Additionally, the Team captain will receive two (2) Cinesol Film Festival Passes for the September 12-14, 2008.

If a team must withdraw from the Film Race, refunds will be paid on the following schedule:

Notify **CINESOL 36** of withdrawal

More than 30 days before competition – Refund Amount \$100;

Between 15 and 30 days before the competition – Refund Amount \$75;

Between 7 and 14 days before competition – Refund Amount \$50;

Notify less than 7 days before competition – No Refund.

Early Bird Registration – Entry Fee \$100.00 before August 15, 2008.

In consideration of my application and of permitting me to participate in this event, I hereby agree for myself, my executors, administrators, heirs, next of kin, successors, and assigns, as follows: (A) I hereby waive, release and discharge from any and all liability for death, disability, personal injury, property damage, property theft or damages of any kind which may at any time accrue as result of or in any way related to **CINESOL 36 HR. I hereby give permission for The **CINESOL 36 HR. FILM RACE** to screen any videos and/or films produced in the course of The **CINESOL 36 HR. FILM RACE**, and to produce a compilation of the best films of 2008, in the sole discretion of The **CINESOL 36 HR.
